This has reference to your letter dated 2<sup>nd</sup> September, 2011, for first time affiliation to start new College of Engineering from the academic year 2011-12 imparting i) Mechanical Engineering, ii) Electronics & Tele Communication Engineering, iii) Computer Engineering, iv) information Technology and v) Civil Engineering branches on the name of G.M. Vedak Institute of Technology, propose to be started at Post & Taluka- Tala, Dist. Raigad- 402 111.

In this connection, I am directed to inform you that considering the permission granted by the above mentioned authorities to your Trust, I am pleased to inform you that your Trust has been granted permission for first time affiliation to start new degree Engineering College on the name of Gopinath Mahadeo Vedak Pratishthan's 'G.M. Vedak Institute of Technology' imparting i) Mechanical Engineering, ii) Electronics & Tele Communication Engineering, iii) Computer Engineering, iv) Information Technology and v) Civil Engineering branches with intake of 60 students in each branch propose to be started at Post & Taluka- Tala, Dist. Raigad- 402 111, on permanently "**No Grant Basis**". To start the first year classes only of the B.E. degree courses with i) Mechanical Engineering, ii) Electronics & Tele Communication Engineering, iii) Computer Engineering, iv) Information Technology and v) Civil Engineering with intake of 60 students in each branch from the academic year 2011-12.

The college has to fulfill the conditions mentioned in the above mentioned letter of the Government of Maharashtra.

The college has also to fulfill the following affiliation conditions and subject to satisfactory report of the L.T.C. appointed by the University as per Maharashtra Universities Act, 1994.

1) that the conditions laid down by the University from time to time.

2) that the minimum attendance of all the students must not be less than 75% during the academic year and college will have to complete syllabus of all the subjects during the academic year.


- 3) admissions should not be linked with donations.
- 4) that they will strictly follow the Ordinance 2802 in respect of preventing the colleges and Management of Colleges from accepting donation or capitation fees for admission of students in the Colleges, quoted in the University Circular No.Aff./Recog./49 of 1987, dated 4<sup>th</sup> February, 1987 (copy enclosed.)
- 5) that they should follow the norms as prescribed by the University from time to time.
- 6) the college shall not admit the students over and above sanctioned intake.
- 7) the college shall appoint the teaching as well as non-teaching faculty as per the University and U.G.C. norms and also provide infrastructure facilities for the purpose.

Further, I enclose herewith the copies of the Circular No.Aff./Recog.I/188, dated 17<sup>th</sup> May, 2008 and No.Aff./Recog.I/189, dated 17<sup>th</sup> May, 2008 for your information and further necessary action.

**In case you could not start the College from the academic year 2011-12, the permission granted to your Sanstha will stand cancelled, which may please be noted.**

Please inform the Name of the College, Address, Telephone No., Fax No. and date on which the college has started and also submit the proposal for continuation of affiliation with the prescribed fee as per Circular No. Aff./Reecog.I/188 of 2008, dated 17.05.2008 immediately, for the academic year 2012-13 and onwards.
